SUBJECT: Update on projects related to sustainability

Please see below for an update on all of the current sustainability related projects for the Department of Public Works and Parks:

State Loan Projects: Successful final walk through with the Department of Economic Development/Division of Energy occurred March 30, 2017.

- Centennial Commons: 1 CO₂ sensor installed
- Centennial Commons lobby pendant lights have been received need to be installed
- City Hall and Centennial Commons fluorescent tubes and exit lights will be replaced this month
- City Hall exit lights will be replaced this month
- City Hall HVAC boiler replacement is complete
- Pool pumps have been replaced with variable speed pumps (last year)
- City Hall Trinity/Delmar lighting have been replaced with LED 75% less energy (last year)
- Centennial Commons Parking Lot lights replaced with LED 60% less energy (last year)
- Centennial Commons Soccer Area Lights replaced with LED 50% less energy (last year)

Received grant for \$50,000 for 95 gallon recycling carts and toward a robust recycling education program. Remaining residential 65 gallon recycling carts will be replaced with 95 gallon carts.

Recycling Drop-Off Grant – have a few issues to work out with the cardboard compactor, plastic film baler installation, and reducing the opening size in the fence (to avoid car doors, panes of glass, and other non-recyclable items)

Commercial Recycling Grant – Completed. 62 additional businesses are recycling in the Loop and the street-side containers have been successful (besides paper cups!)

MS4 – Jenny participating in the Third Term St. Louis County Stormwater Management Plan Planning Committee. The goal is to come up with a county-wide stormwater management plan in accordance with MS4 goals (municipal separate stormwater system).

Electronics (and Styrofoam) Recycling Event – Scheduled for May 6, 2017.

City will participate in the USGBC Green Cities Challenge (a branch of the Green Business Challenge) again this year, this runs from April through December.

Green Business District Challenge – Working with the Loop Special Business District and Earthways Center (Jean Ponzi) to start a green business district in the Loop. This is another layer of the Green Business Challenge geared toward small businesses who can group together to accomplish green goals.

St. Louis County Department of Public Health: Staff applied for a commercial recycling program for Olive Boulevard since the Loop commercial recycling grant was so successful.

Delmar Blvd pedestrian lights – We are working with a vendor replacing replacement of the Delmar pedestrian lights with LED in FY2017 (by the end of June this year)

Stormwater Runoff at the Nursery – We are working with a consultant and the River Des Peres Coalition to solve some of the leachate and erosion issues at the nursery.

Staff is a part of the Regional Stormwater Management Plan planning committee with other members of the community from MSD, St. Louis County, MoDOT, Missouri Coalition for the Environment, Home Builder's Association, and the Cities of Bellefontaine Neighbors, Ladue, and Creve Coeur.

We will then approve the sector plan in the following month's meeting.

During the March meeting, we established the goal of creating a document that was easy to reference and use, and would be beneficial for Council Members to make decisions regarding sustainability. We also hoped that the document would reflect the specific challenges and assets of University City, relative to social, economic, and environmental sustainability.

The Sustainability Strategic Plan is intended to be completed by the end of 2017.
