Please see below for an update on all of the current sustainability related projects for the Department of Public Works and Parks:

State Loan Projects: Energy Resources Group has been hired to perform a financial analysis of the state loan projects to audit the projects and assist finance department on how the payments should be budgeted.

2017 Solid Waste Management District Grant: Awaiting \$50,000 for 95 gallon recycling carts and toward a robust recycling education program. Remaining residential 65 gallon recycling carts will be replaced with 95 gallon carts.

2017 St. Louis County Department of Public Health: Staff has received notice of funding for a commercial recycling initiative for Olive Boulevard businesses.

2015 Recycling Drop-Off Grant: Plastic film baler will be installed late May/early June. Conveyor and space issues still need to be worked out with the cardboard compactor and reducing the opening size in the fence (to avoid car doors, panes of glass, and non-recyclable items).

MS4: University City has been participating in the Third Term St. Louis County Stormwater Management Plan Planning Committee. The goal is to come up with a county-wide stormwater management plan in accordance with MS4 goals (municipal separate stormwater system). Other members of the committee include MSD, St. Louis County, MoDOT, Missouri Coalition for the Environment, Home Builder's Association, and the Cities of Bellefontaine Neighbors, Ladue, and Creve Coeur.Final goals have been formed and will be distributed to the planning committee soon.

Electronics (and Styrofoam) Recycling Event: Successfully executed May 6, 2017. 20,000 pounds (10 tons) of electronics collected

City will participate in the USGBC Green Cities Challenge (a branch of the Green Business Challenge) again this year, this runs from April through December.

Green Business District Challenge: Working with the Loop Special Business District and Earthways Center (Jean Ponzi) to start a green business district in the Loop. This is another layer of the Green Business Challenge geared toward small businesses who can group together to accomplish green goals.

Delmar Blvd pedestrian lights: Working with a vendor replacing replacement of the Delmar pedestrian lights with LED in FY2017 (by the end of June this year)

Stormwater Runoff at the Nursery: We are working with a consultant and the River Des Peres Coalition to solve some of the leachate and erosion issues at the nursery.

Staff began an internal recycling education workshop to all City staff during "Public Works Week" – May 22 – May 26. Solid Waste Division was trained first, next up: Streets and Parks Division.

Greenhouse Gas Inventory/Climate Action Plan: Staff is working with Tim Schmalz, the intern working on the Greenhouse Gas Inventory, reviewing the Greenhouse Gas inventory and developing the Climate Action Plan – which includes mitigation and adaptation. The City needs to work on developing the portion pertaining to the climate hazards and the vulnerabilities faced by the City.

Home, Health, and Energy Resource Fair: May 13 was the CAASTL Resource Fair at the Community Center from 10am – 1pm. It was a successful event.

Transportation Alternative Program Grant Application: Staff is working on submitting 2 applications for this grant; one connecting the current bike routes through University City and the other updating the lighting and ADA access along Ackert Walkway.

University City is part of a regional group working on regional recycling education and standardizing the recycling message. The main goals of the group are Education and Policy, with the first action items as follows:

- Create a common list of recyclables for everyone in the 5 county region to use: (Franklin, Madison, St. Louis, St. Charles, Jefferson)
- Creation of a stakeholder group of county, city, muni personnel, landfill, hauler, recyclers, and other entities directly involved and critical in the message distribution.

University City applied for the Mayor's Climate Protection Award for the sustainable actions that the City and its partners have made in the Loop, including:

- Permeable Pavers
- LED lighting
- Cigarette Butt recycling
- Streetside Recycling Containers
- Increased Commercial Recycling
- Green Dining Alliance District

Staff submitted the City's first "Green Page" to be distributed in the ROARS Newsletter.

The Park Commission and Staff have decided to create a "Stormwater Management" Task Force to begin working on a Stormwater Management Plan for University City.

- 1. Meeting Called to Order, Roll Call at 6:04 p.m.
- 2. Opening Round
  - a. Lois presented at a healthcare sustainability conference on green purchasing practices in Minneapolis

#### 4. Special Presentations

- a. Tim Schmalz reported the outcomes of the Greenhouse Gas Inventory
  - i. Total emission for University City dropped by 13%
  - ii. Government operations dropped by 1% a minor drop because of increase in City facilities square footage at Centennial Commons and the new firehouse.
  - iii. Commercial energy use and solid waste both increased.
  - iv. Firehouse 1 is new but has poor energy performance. The Commission recommends retro-commissioning to test performance.
  - v. Tim is working on the climate action plan and will report back to the Commission.
