Existing Conditions:

Lindell Blvd from Asbury Ave and Manhattan Ave.



A portion of this request was submitted at the June 14, 2017 Traffic Commission Meeting for half of the block. After further review and participation the residents would like the entire block to be included in the Residential Parking Permit Request.

Lindell Boulevard between Asbury Ave and Manhattan Ave has no parking restrictions. Both sides are available for parking.

The Street is within one (1) block from both a municipal boundary and Washington University, thus is eligible for a Residential Parking Permit system.

Request:

Implement a Residential Parking Permit System on Lindell Boulevard between Asbury Ave and Manhattan Ave, on both sides of the street.

The petition submitted included signatures from 42 property owners, out of 46 properties in the requested area. This constitutes 91% of property owners in agreement.

Conclusion/Recommendation:

It is recommended that the Traffic Commission approve the newly submitted petition that includes that entire 7200 Block of Lindell Avenue.

LOCATION OF REQUEST:

7200 block of Lindell. See attached property map.

STATE THE NATURE OF YOUR REQUEST: The residents would like to establish a residential permit parking zone that would be in effect for about 2/3 of the 7200 block of the Lindell. The surrounding blocks of Forsyth, Maryland and Westmoreland have Residential Permit Parking restrictions in place. The 7100 block of Lindell is also pursuing Residential Permit Parking. The area under consideration is primarily single family homes. The remainder of the block has more multi-family and rental units.

WHAT ACTION ARE YOU REQUESTING THAT THE CITY TAKE CONCERNING YOUR REQUEST? There is substantial agreement from about 75% of the residents who want to pursue Residential Permit Parking in the area indicated on the map. We would like the City's support of this request.

WHAT IMPACT WOULD THE ACTION HAVE ON ANY ADJACENT RESIDENTS OR STREETS? This should have limited impact on adjacent streets, which already have restrictions. In addition, most of the homes on the streets to the north of Lindell have garages. Many of the homes on the 7100 block of Lindell do not have garage or off-street parking and therefore residents need to park on the street.

NOTE: The Public Works Department staff will review this request and, if warranted, this matter will appear as an agenda item for a traffic commission meeting. If a meeting is held, you will be encouraged to attend so that you may state your concerns.



Existing Conditions:

Northmoor Drive from Big Bend Blvd to Asbury Ave



At the July 12, 2017 Traffic Commission meeting, a motion was passed to request a petition for the Residential Parking Permit.

Request

Implement a Residential Parking Permit System in the 7000-7100 block of Northmoor Drive between Big Bend Blvd and Asbury Ave Asbury Ave, on both sides of the street (per the Traffic Commission recommendation from July 12, 2017).

Residential Parking Only from 8 a.m. to 5 p.m., Monday through Friday.

The petition submitted included signatures from 40 property owners, out of 46 properties in the requested area. This constitutes 87% of property owners in agreement.

Conclusion/Recommendation:

City Staff recommends that the Traffic Commission approve the petition as presented.

STATE THE NATURE OF YOUR REQUEST: The residents would like to establish a residential permit parking zone for the 7000 and 7100 blocks of Northmoor Dr. The surrounding blocks of Forsyth, (north side) and Lindell 7000 (and 7100 and 7200 are under consideration) have Residential Permit Parking restrictions in place. The area under consideration is primarily single family homes with the exception of a few park parcels owned by the City of University City and three parcels owned by the Archdiocese of St. Louis for use of Our Lady of Lourdes school and rectory buildings. Residential Permit parking is being pursued because Northmoor is immediately adjacent to Washington University's South 40 housing area. Freshman and Sophomore who reside on the South 40 are prohibited from bringing cars to campus and sometimes park vehicles for several days at a time on Northmoor.

WHAT ACTION ARE YOU REQUESTING THAT THE CITY TAKE CONCERNING YOUR REQUEST? There is substantial agreement from more than 75% of the residents who want to pursue Residential Permit Parking in the area indicated on the map. We would like the City's support of this request.



If these concerns cannot be addressed, that we would seek to have only a portion of the 7100 block included in the Residential Permit Parking district to accommodate the concerns of Our Lady of Lourdes School.



We have frequent non-resident parkers associated with Washington University who remained parked throughout the day.

Residential Permit parking is being pursued because Northmoor is immediately adjacent to Washington University's South 40 housing area. Freshmen and sophomores who reside on the South 40 are prohibited from bringing cars to campus and sometimes park vehicles for several days at a time on Northmoor Drive. Non-resident parking makes it difficult to access our driveways or park in front of our homes.

The request could have an impact Our Lady of Lourdes School and Church. To remedy that, we would ask that the Residential Permit Parking hours are 8 a.m. to 5 p.m. Monday-Friday. Further we would request that Lourdes teacher be considered "residents" and that they be able to park on Northmoor without restrictions as they have no other place to park.

Our building is on the southeast corner of Forsyth Blvd. and Del Lin Avenue. Our driveway is directly across from Crazy Bowls and Wraps, a beauty salon, and Krueger's bar and grill. We are less than a block from the Forsyth Metro stop and are walkable to Washington University.

There is a No Parking Anytime to the west of our driveway (between our driveway and the intersection of Forsyth and Del Lin). We are requesting that the sign stating No Parking Here to Corner be placed to the east of our driveway at least one car length from our entrance. This is because cars frequently park right up to our driveway going east. And, at times our driveway is obstructed. During the academic year many university students use charter busses for large groups for traveling to entertainment within the city. The buses sit idle while loading and unloading disturbing the neighborhood during the late evening hours.

Request:

Prohibit charter buses from pick up or drop off in the 6600-6800 Block of Kingsbury Ave.

Conclusion/Recommendation:

The City has an ordinance that prevents any vehicle from idling longer than 3 minutes, this can be enforced. It is recommended that the Traffic Commission determine if there should be a petition requested for the prohibition.

LOCATION OF REQUEST:

6600-6800 Block of Kingsbury

STATE THE NATURE OF YOUR REQUEST: During the academic year, this street frequently serves as the point of departures and returns for large charter buses. These buses generally have been chartered by students to take large groups to off-site locations such as Laclede's Landing. The buses idle loudly, generally around 9 or 10 p.m. when permanent residents are trying to go to sleep. The buses return in the early morning hours, letting off large groups of students who can be noisy and disruptive.

WHAT ACTION ARE YOU REQUESTING THAT THE CITY TAKE CONCERNING YOUR REQUEST? We are requesting that the City officially prohibit charter buses from pick up or drop off on Kingsbury, and that if they do so, a ticket and fine can be issues to the charter operator. This could be accomplish through a no-load zone or similar. These activities could occur on Washington and be less disruptive to permanent residents.

Dear Mr. Tate,

It has come to my attention that several neighbors in the 6800 and 6600 blocks of Kingsbury have filed a request for the Traffic Commission to consider the creation of a No Commercial Loading Zone along Kingsbury Avenue.

This request is being made to address a persistent problem of charter buses which load and unload on the street in the late night/early morning hours and disrupt the neighborhood.

Washington University has sought to address this issue in the past. When buses are reported, we send Washington University Police Officers to ask the vehicle to move and suggest more appropriate location for loading. We attempt to determine the individual that ordered charter bus and educate him/her on appropriate neighborhood protocols.

A posted no-loading zone and the ability for University City Police Department to issue a ticket or charge a fine, would be a significant deterrent to this repeated activity.

Washington University is in support of this request.

STATE THE NATURE OF YOUR REQUEST: During the academic year, this street frequently serves as the point of departures and returns for large charter buses. These buses generally have been chartered by students to take large groups to off-site locations such as Laclede's Landing. The buses idle loudly, generally around 9 or 10 p.m. when permanent residents are trying to go to sleep. The buses return in the early morning hours, letting off large groups of students who can be noisy and disruptive.

WHAT ACTION ARE YOU REQUESTING THAT THE CITY TAKE CONCERNING YOUR REQUEST? We are requesting that the City officially prohibit charter buses from pick up or drop off on Kingsbury, and that if they do so, a ticket and fine can be issues to the charter operator. This could be accomplish through a no-load zone or similar. These activities could occur on Washington and be less disruptive to permanent residents.

WHAT IMPACT WOULD THE ACTION HAVE ON ANY ADJACENT RESIDENTS OR STREETS? This action would only have a positive impact on adjacent residential neighbors who will not be regularly disturbed during the late evening/early morning hours.

Good Morning Mr. Tate, after a more specific discussion with Cirri, the neighbor and applicant named on our request form regarding the Party Bus problem, we have come up with this amendment to our initial request. It is important.

The buses need to be banned from traveling South of Washington along the North/South streets of Kingsland, Trinity and Melville coming into this residential neighborhood. Here's why:

1. The 3 N/S streets are very narrow. Parking is permitted. Buses block the streets completely. There is no way to pass. Emergency vehicles could not get through.
2. If buses are merely banned from loading and unloading on Kingsbury Blvd. but can still travel on Kingsland, Melville and Trinity, they can continue to travel down Kingsbury and then pull around to these N/South streets to load and unload.
3. Many apartment dwellers have bedrooms adjacent to the streets. It is a terrible situation late at night.
4. The mere physical act of the big buses with their diesel motors and loud braking driving down the residential streets is disruptive to sleep.
5. If buses can load and unload in the 500 block of Kingsland, they will disturb me and my residents as they have for the last 20 years.
6. That would make all this effort useless because it would not benefit anyone living in the big apartment buildings across from the single family dwellings.

Thank you for your help in expediting this request at the beginning of Wash U's fall semester when it is greatly needed.


