- 1. Meeting Called to Order Roll Call at 5:33 Special Guests: None
- 2. Opening Round:
 - a. Lois Coordinates Green Practices for a Health System, annual report will be out soon.
 - b. Kathy Concerned about incorrect recycling.
 - c. Jenny Passed out standard message for Recycling Right and the dangers of "wish-cycling", where trash is thrown in the recycle bin in the hopes that it could possibly be recycled.

3. Approval of Minutes

a. The 11/09/17 minutes were approved with minor revisions.

4. Special Presentation - None

5. New Business

- a. Welcome new members: Timothy Dugan and Kathleen Straatman Commissioners discussed their backgrounds:
 - i. Lois Sechrist: Founding member of the Green Practices Commission, has a career in green practices.
 - ii. Timothy Dugan: From Boston, lived in University City since 2014. Works at the Gephardt Institute for Civic and Community engagement.
 - iii. Kathy Straatman: First meeting, active in University City Politics, lived here since 1989, Owns 2 apartment buildings in University City.
 - iv. Jonathan: 10 year resident of University City. Teaches Urban Design.
 - v. Adam Staudt: Lived in University City since 2001. Owns a construction company based out of University City.
 - vi. Barbara: 33 year resident of University City, worked in libraries for 35 years, recently completed the Master naturalist Program.
 - vii. Jenny: Worked for University City for 8 years. Background in environmental chemistry. Now a project manager handling energy efficiency, solid waste, and other unrelated projects.

- viii. Adam Brown: Moved to University City from the east coast in 2016, has a degree in City and regional planning from Cornell. Working on Neighborhood outreach and collaborating across departments.
- b. Recycling Ordinance for construction projects discussion Jenny presented recycling ordinances from other locations across the country. The commission discussed the following factors:
 - i. Check University City's database of construction/demolition companies.
 - ii. Start with developing and providing the businesses with educational material about reducing waste and the cost-savings of recycling instead of landfilling. In addition it is good social capital for businesses.
 - iii. First step of requiring City projects to recycle cardboard and metal with the recommendation to construction/demolition projects to follow the City's ordinance.
 - iv. If and when ordinance implemented, can be tied to rough-in or final inspection.
 - v. Determine what recycling outlets are available for Construction and Demolition waste (other than LEDR and ECO).
 - vi. Creating an ordinance like this has been a multi-year process for other municipalities.
- 6. Old Business
 - a. Sustainability Strategic Plan Review Jonathan will compile the documents into 1 file and send a google document to the group.
 - b. Climate Action Plan (CAP) Update Lois will finish summarizing the CAP and send it to the group.

- b. Quarterly Report Ecosystems/Habitat: Barbara Brain discussed her research findings regarding what other parts of the country are doing about native plants.

 Boulder, Colorado has an ENVIRONMENT tab on the website focusing on Climate, energy, water, waste, and ecosystems with information on the benefits of trees and a list of trees native to the area. Boulder is a bee friendly city with a tagline of "Beefriendly Boulder". The ecosystem section has a large focus on Integrated Pest Management (IPM) – The Long term prevention or suppression of pest problems while minimizing the impact on human health, the environment and non-target organisms. The City cannot use herbicides or pesticides on City property. There is a neighborhood with over 200 neighbors dedicated to keeping bees safe, designated as "Bee Safe" neighborhoods.

- ii. Austin, Texas has a large part of their website devoted to Environmental programs. One program, Grow Green, is a gardening education program promoting sustainable landscaping. The website has "Grow Green Landscape Professional Training" available.
- iii. Minneapolis Minnesota has a program called The Corcoran Pollinator Project, a grassroots initiative encouraging neighborhood pollinator gardens. The project has successfully completed 10 Boulevard gardens with 40 species of pollinator plants.

8. Closing Round

RECYCLING TIPS and FAQs

- No Need to Rinse! Containers do not need to be rinsed clean, just emptied.
- Keep lids on so they get recycled! They will get lost otherwise.
- Flatten cardboard! That way you have as much room as possible to recycle what you can.
- Do not bag recyclables! Put items directly into the recycling container loose.
- Recycle those pizza boxes! Even with a bit of grease, sauce or cheese.
- Plastic bags, dry cleaning bags, newspaper sleeves, bubble wrap, bread bags, case overwrap, and produce bags can all be recycled at <u>975</u> <u>Pennsylvania</u> or at your local grocery store!
- Recycling Saves University City \$\$\$! Increasing residential recycling by just 20% would save the City \$100,000 every year for improvement projects.
