Location: Williams Ave - Between Pershing and Forest FPPW

Request: Residential Parking Permit request

Existing Conditions:



Williams Avenue between Pershing Avenue and FPPW has no parking restrictions. Both sides are available for parking.

The street is within two blocks of Washington University or another municipality's boundary and the problems caused by nonresident parking* on the block are chronic and well-documented.

The street is within one (1) block from both a municipal boundary and Washington University, thus is eligible for a Residential Parking Permit system.

Request:

Implement a Residential Parking Permit System on Williams Avenue between Pershing and FPPW on both sides of the street.

Conclusion/Recommendation:

It is recommended that the Traffic Commission determines the list of affected households for a petition to implement the residential parking permit system.


APPLICANT: Margaux Weller– 8131 Amherst Ave

Location: Elementary and Secondary Education Institutions

Request: Inclusion in Residential Parking Areas

Attachments: None

Existing Conditions:

Currently there is no ordinance that allows for elementary-secondary education employees to have the option to park within the Residential Parking Permit area that there institutions area adjacent to.

Request:

Develop a new code under section 300 for elementary-secondary education institutions parking.

Conclusion/Recommendation:

In this new code the requesting institution will have to first provide staff with a site plan outlining the available space within their property. At that time it will be determine what the required number of spaces are for the institution to operate, in accordance with the zoning code. Staff would recommend the traffic commission support the allowing of these institutions to apply for a parking zone around the perimeter of the institution during school hours only. We would ask that the neighborhood the institution is in support the new parking plan. This can be determined either by petition or survey.

Request: Lime/Scooter Policy

Although a bike/scooter share program has not been set up in University City, the bikes are here.

Summary:

The City of University City would like to evaluate all aspects of a dock-less bike/scooter share program to determine if it is right for University City and program parameters that need to be developed for University City; i.e. bike-share policy and permitting structure, distribution and removal of bikes, reporting, etc.

Staff is requesting input from the Traffic Commission on dock-less bike/scooter share program policy development.

Neighboring Community Policies:

- The City of St. Louis currently has a bike-share permitting system and has permits with Lime.
- Washington University has entered an agreement with Lime via contract. Parameters have been set in the contract indicating parking locations, timely removal of bikes left at unauthorized "red zone" locations, etc. -

• The City of Clayton is allowing Lime to place bikes but will not enter into a contract, sign an MOU, or sign an agreement. The City of Clayton only asked the bike-share programs to add Clayton to their insurance.

Recommendation:

Staff has performed preliminary research of local use of bike/scooter share programs and determined that the development of governing policy is the best avenue for University City to embark on a bike/scooter-share program. With the assistance of the City's traffic engineer, an evolving policy for Lime and other similar companies will be developed. Restrictions can be set in the agreement including but not limited to:

- Specific docking areas
- Municipal code regarding bikes and motorized modes of transportation
- Red zones where bikes need to be removed within a set number of hours
- Safety/Maintenance of bikes
- Reporting
- Local customer representative access
- Termination clause
- In terms of the scooter what makes it eligible
- Age of the scooter riders

These same parameters (and more) can be set in a long-term bike-share program if the City of University City chooses to proceed.
