Agenda Item #1: Call Meeting to Order

Absent were Commission Vice President Barbara Chicherio and Commission Member Mary Harvey.

Agenda Item #3: Approval of Agenda

Commission Member Teixeira motioned and Commission Member Logan seconded to approve the agenda with no changes. The motion was approved unanimously.

Agenda Item #4: Approval of Minutes

Commission Member Teixeira motioned and Commission Member Rowan seconded to approve the minutes of September 11, 2019 with no changes. The motion was approved unanimously.

Agenda Item #5: Citizens' Comments

Kathy Freese shared the mission/vision of her volunteer organization Tree Keepers with the Commission. She hopes that University City will sanction her group in order to attract more volunteers and to spread the word about the organization. Tree Keepers volunteers will plant, mulch, pull weeds, go door to door, whatever it takes to get more trees for University City. She is currently working with Forester Kaiser and Director Dunkle developing a plan for continued work with this organization which includes a volunteer handbook. Webster Groves has a similar organization. Kathy has been a member of Forest Relief for twenty years.
