A. MEETING CALLED TO ORDER

At the Regular Session of the City Council of University City held on the fifth floor of City Hall, on Monday, February 24, 2020, in the absence of Terry Crow, Mayor Pro Tem Paulette Carr called the meeting to order at 6:30 p.m.

B. ROLL CALL

In addition to the Mayor Pro Tem, the following members of Council were present:

Councilmember Stacy Clay Councilmember Steven McMahon; (Excused) Councilmember Jeffrey Hales Councilmember Tim Cusick Councilmember Bwayne Smotherson

Also, in attendance were City Manager, Gregory Rose, and City Attorney, John F. Mulligan, Jr.

C. APPROVAL OF AGENDA

Mr. Rose requested that Items I (1), L (2), and M (1) be removed from the Agenda and reposted at a later date.

Councilmember Cusick moved to approve the Agenda as amended, it was seconded by Councilmember Smotherson and the motion carried unanimously.

D. PROCLAMATIONS

1. 100th Anniversary 19th Amendment – A declaration commemorating the 100th Anniversary of the Women's Constitutional Right to Vote and founding of the League of Women Voters.

Mayor Pro Tem Carr read the attached proclamation into the record.

E. APPROVAL OF MINUTES

- 1. January 27, 2020, Study Session Minutes; Storm Water Task Force Report were moved by Councilmember Clay, it was seconded by Councilmember Smotherson and the motion carried unanimously.
- **2.** January 27, 2020, Regular Meeting Minutes were moved by Councilmember Hales, it was seconded by Councilmember Clay and the motion carried unanimously.
- **3.** February 10, 2020, Study Session Minutes; Hotel Feasibility and Scooters were moved by Councilmember Smotherson, it was seconded by Councilmember Clay and the motion carried unanimously.
- **4.** February 10, 2020, Regular Meeting Minutes were moved by Councilmember Smotherson, it was seconded by Councilmember Clay and the motion carried unanimously.

F. APPOINTMENTS TO BOARDS & COMMISSIONS

1. Patricia McQueen is nominated to the Plan Commission as a fill-in replacing Cynthia Head (1/1/20-1/1/23) by Councilmember Clay, it was seconded by Councilmember Smotherson.

Councilmember Cusick stated his understanding is that Ms. McQueen resigned from CALOP in order to participate on this Commission. So he would like to personally thank Ms. McQueen for her many years of service on CALOP and continued interest in supporting this community.

Voice vote on the motion to approve carried unanimously.

G. SWEARING IN TO BOARDS & COMMISSIONS

H. CITIZEN PARTICIPATION (Total of 15 minutes allowed) Aren Ginsberg, 430 West Point Court, University City, MO

Ms. Ginsberg stated last week a U City resident was threatened with fines for feeding fixed feral cats. In response, the U City Trap, Neuter, Vaccine & Return (TNR) volunteers would respectfully like to share this Petition signed by more than 600 cat advocates in support of a Protective TNR Ordinance for U City. Unfortunately, the feeding, sheltering, and veterinary care of fixed feral cats by compassionate neighbors is not protected under the current Municipal Code. So today, these folks risk expensive fines and their neutered and vaccinated cats are in danger of euthanasia.

Ms. Ginsberg stated U City's TNR was formed in October of 2018, and since that time volunteers have successfully,

- Trapped, neutered, and vaccinated more than 50 community cats;
- · Partnered with local rescue groups;
- Found furr-ever homes for 12 U City strays, and
- Shared the *ICMA's Guide to Managing Community Cats*, along with dozens of articles to show how TNR effectively stabilizes and reduces feral cat populations

Her belief is that TNR addresses neighborhood safety concerns and has effectively saved taxpayer dollars. Therefore, she would respectfully ask U City to adopt a Protective TNR Ordinance.

Donna McGhee, 7584 Melrose, University City, MO

Ms. McGhee stated in addition to the constant debris created by the huge Sycamore Tree that extends across her property line, recently, two "widow-maker" branches fell down on her driveway. In forestry terms "widow-maker" refers to detached or broken limbs that can create hazardous conditions, including fatalities to forestry workers, neighbors, property, and pets. She stated while she is appreciative of Mr. Dunkle, Mr. Alpaslan, and the members of their staff who have always been very attentive to her concerns, she wants to make sure the City is aware that the condition of this tree could result in some serious liability issues. The bottom line is that she would love to have this tree removed from the base of her driveway and replaced with a smaller seedling that she would even be willing to pay for.

J. CONSENT AGENDA – Vote Required

1. Hotel Feasibility Study Acceptance (HVS Consulting)

Councilmember Clay moved to approve the Consent Agenda, it was seconded by Councilmember Cusick.

Councilmember Smotherson asked Mr. Rose why Council's approval was needed for this study? Mr. Rose stated the Study was initially presented to Council in a draft format. So Council's acceptance acknowledges that the study has been completed, all remaining payments to HVS Consulting can be processed, and staff now has the approval to use this study as a marketing tool that can be provided to developers who express an interest in building a hotel within the City. Councilmember Smotherson questioned whether this was a commitment from Council to pay for the Study? Mr. Rose stated while it does enable staff with the authority to finalize all payments, it's also Council's okay to use the study as a marketing tool.

As you are aware, Wash U is considering development options for land located on Forsyth, so a copy of this study will be provided to them as an incentive to at least think about including a hotel as part of their development.

Councilmember Clay stated initially that same question had come to mind until he thought about the School Board's acceptance of similar reports or studies. Because absent the Board's official adoption of a document, its contents could not be referenced or used for the purposes articulated by the City Manager.

Voice vote on the motion to approve the Consent Agenda carried unanimously.

K. CITY MANAGER'S REPORT

1. Loop Ice Carnival Budget Review

Mr. Rose stated staff is recommending that Council consider The Loop Ice Carnival Budget Review that will be presented by Mr. Schmidt of the LSBD Board.

Mr. Schmidt stated the total cost for The Loop Ice Carnival which was held in January of this year, is \$67,241.26. To reduce the overall costs this amount will be split 50/50 between the LSBD and The East Loop CID.

Mayor Pro Tem Carr asked Mr. Rose if these budget requests were typically considered before or after the event? Mr. Rose stated in the future, the practice will be to present requests for funding prior to the event. Mayor Pro Tem Carr asked if a vote of Council was required at this time? Mr. Rose stated if there are no objections, staff will make sure all of the monies have been received from the East Loop before the release of any funds.

Councilmember Clay moved to approve, it was seconded by Councilmember Cusick and the motion carried unanimously.

2. Requesting Funds by LSBD for FY2019 Final Reimbursement

Mr. Rose stated staff is recommending that Council consider a request by the LSBD Board for their Final FY2019 Reimbursements as presented by the Director of Finance, Keith Cole.

Mr. Cole stated the LSBD's request of \$6,946.23 represents the remaining reimbursement funds from FY2019, which will be paid out of the EDRST Fund Reserve.

Councilmember Cusick moved to approve, it was seconded by Councilmember Smotherson.

Mr. Rose stated as a result of the Finance Department's inability to completely reconcile all of the prior accounts submitted by the LSBD Board; specifically with respect to EDRST funds, staff has established a separate bank account for the District. He stated staff was able to identify reimbursements for their FY2019 brochures but have not been able to identify any reimbursements for prior years.

Voice vote on the motion to approve carried unanimously.

 Metropolitan St. Louis Sewer District (MSD) New Easement Request – 82nd Blvd. to I170 Sanitary Relief (MSD Project #11993)

Mr. Rose stated staff is recommending that Council consider a request from MSD for a new easement, which will be presented by the Director of Public Works, Sinan Alpaslan.

Mr. Alpaslan stated this is a request by MSD to revise easements previously granted for the 82nd Boulevard Sanitary Relief Project that is currently under construction. The reasons for this request are twofold:

- 1. The original design did not account for an underground duct bank that would be too costly to relocate, and
- 2. The transfer of one tunnel shaft near the intersection of Creeksdale Lane and McKnight Road will allow MSD to accommodate residential traffic and eliminate the need to completely close the intersection.

Mr. Alpaslan stated MSD has agreed to vacate the easements previously granted and reimburse the City in the amount of \$13,000.

Councilmember Hales moved to approve, it was seconded by Councilmember Cusick.

Councilmember Smotherson questioned whether any of these revisions were in the City's redevelopment area? Mr. Alpaslan stated both revisions are located on the East side of McKnight Road.

Mayor Pro Tem Carr asked whether all of the previous easements would be vacated? Mr. Alpaslan stated some of the areas overlap, and in those instances, the previous easements will remain in effect. So only the areas that are no longer needed will be vacated.

Voice vote on the motion to approve carried unanimously.

L. UNFINISHED BUSINESS

1. Bill Number 9398 was read for the first time.

Mayor Pro Tem Carr requested that Amended Bill No. 9398 be filed with the City Clerk, and that the original version of Bill No. 9398 be amended accordingly. It was seconded by Councilmember Cusick.

City Attorney, John Mulligan advised Mayor Pro Tem Carr that the Amended Bill had already been filed with the City Clerk, and the first reading of that amendment has just been made. So unless her desire is to proceed to a second reading, third reading, and a vote, no other action need be taken tonight? Mayor Pro Tem Carr stated her only desire was to make sure Council was accepting the Amended Bill.

P. COUNCIL COMMENTS

Councilmember Hales thanked the City Manager, Police Department, Code Enforcement, and everyone involved, for the terrific success of the Mardi Gras festivities held over the weekend. In fact, this event was so uneventful that he received a number of emails from residents commenting about how this was the quietest Mardi Gras they have experienced in sixteen years. He stated the coordination between the City's Police Department and Wash U's combined forces was pivotal.
