Staff Liaison Report

Ms. Euell-Taylor reported that 1) signage for the Sculpture Series installations is ready for student pick-up, 2) digital signage is in place at Olive at Pennsylvania and at Centennial Commons, 3) she has met with MSW (PR) and has confirmed Arts & Letters representation with them, 4) we should send press release or other information to her to be forwarded to Ms. Riganti and the appropriate organizations, 5) we should respond to email from Ms. Euell-Taylor requesting corrections or other editing of information sent to us.

Council Liason Report

Ms. Welsch reiterated the request for editing responses. The Better Block event is to be held next weekend. University City has been awarded a Make-a-Difference grant of \$10,000 that is to be donated to SHED.

- RAC grant Our application is in progress. We will work on a MAC strategic grant to underwrite one Saturday concert to be submitted in the next couple of months.

New Business

Fair U. City – the school district has requested a donation from A&L. Ms. Sullivan pointed out the likely depletion of our funds—what are the plans and greatest need? Marketing suggests placement of our brochures at the City table. Ms. Thomas suggests that she might volunteer to work with children and to talk with other organizations. We will consider a donation at our next meeting.

Other Business

Ms. Euell-Taylor provided a new phone list and schedule for agenda submission.

Ms. Sullivan explained that, because of security concerns, the intention to submit Treasurer's Report by email is not wise and hard copies only will be made available.

Ms. Henderson reported that Ms. Reed will be working with Starlight concerts and schools.

Ms. Henderson requested a volunteer to attend the next Fair U. City meeting. Mr. Burr agreed to join her as A&L representatives.
