#### Agenda Item F: Department Report

- 1) Mr. Dunkle reported that with the recent COVID orders from the County, staff has had to develop and submit operations plans for the tennis courts and golf course describing how the City planned on complying with the new guidelines.
- 2) Mr. Dunkle was asked when the netting was scheduled to be replaced at the driving range. Mr. Dunkle reported that he was waiting on the receipt of the Contract, Insurance and Performance Bond. He further stated that once these items had been received, he would issue a Notice to Proceed.
- 3) Mr. Dunkle was asked why Kaufmann and Kingsland Park Playgrounds were closed. Mr. Dunkle reported that both playgrounds did not meet surfacing standards, thus they would remain closed until the surfacing was replaced in the spring.
- 4) Mr. Dunkle reported that the City had received the Municipal Parks Grant for the Ackert Park redevelopment project and that a Consultant would be brought on board soon and work will begin on the Design Development stage of the project.
- 5) Mr. Dunkle was asked if the indoor soccer field was open as the Sporting St. Louis soccer group has flyers stating that Centennial Commons is one of their locations for events. Mr. Dunkle stated that Centennial Commons remains closed and that the City hasn't issued any permits for such use.
