The meeting was called to order at 6:15 pm by Gloria Nickerson, President.

Minutes: Ms. Huether moved to accept the March 13th minutes with the correction of removing County Older Adult Commission Report from future agendas; Ms. Hewitt seconded. Minutes approved by acclamation.

Citizen Comments: none

Staff Liaison Report: Ms. Euell-Taylor provided an update on status of recreation facilities, with there being a possibility of summer reopening; though definitive dates have not been determined and shared information regarding seasonal/part time employment opportunities with the Recreation Division and Ruth Park Golf Course.

Council Liaison Report: Councilmember Klein gave the following overview: 1.) Current building demolitions: Delmar School, High Rise at Delmar/1170 and former Pasta House location. 2.) Costco/1170: developer has acquired all necessary properties; unsure when groundbreaking is planned; contractors will be required to have a % of minority participation; funds appropriated to assist businesses to remain in University City; City working on plan to provide least amount of disruption through area and neighborhoods during construction. 3.) Bond issue schedule to be on August 3rd; will focus on renovation of City Hall Annex (for relocation of University City Police Department, Municipal Courts and City Council meetings; along with repairs to City Hall.

New Business:

- President Nickerson recommended Commissioners review their binder material with a focus on tabs #2, #4, #5, #9 and #10. It was also recommended that a future meeting be used as an in-service on the roles and responsibilities of the Senior Commission.

Old Business:

- Councilmember Klein and Park Director Dunkle provided an overview on the reinstatement of the Senior Services Coordinator position.

Other Updates/Topics of Concern: Commissioners discussed reviewing previous senior surveys to determine immediate needs of resident seniors.
