Call to Order: Board Chair Michael Alter called the meeting to order at 10:04 a.m. and took attendance of those on the call.

Public Comments: There were no public comments submitted.

Approval of the Minutes: Mary Gorman made a motion to approve the May 13, 2021 minutes, Wendy Harris seconded the motion, and it carried unanimously.

City Hall Updates: Mayor Terry Crow shared that University City has determined they will not not need to issue a bond to assist with the construction of new police station inside the historic annex building. The University City swimming pool is back open and positions are available for lifeguards. City Council will be resuming in person meetings in the near future. Mayor Crow thanked Audrey Jones for all of her hard work with Mannequins on the Loop. Mayor Crow thanked the University City Police for their fast response and diligent efforts in identifying a suspect that was apprehended.

Security Update: Captain Dana Morley reported that National Night Out Back to School Ralley will take place on Tuesday, August 3rd from 5-8 pm at Jackson Park Elementary School. Volunteers are needed for this event. Washington University has partnered with the University City police department to bike patrols Thursday through Saturday morning. The non-emergency police department number is 314-725-2211.

Mannequins on the Loop: Audrey Jones reported that there are 19 mannequins on display on Delmar with the theme focused around recycling. The awards reception and finale will take place on June 13 at the University City library and will be streamed live on Facebook. Steve Stone and Michael Alter thanked Audrey for another amazing year of Mannequins on the Loop.

Vintage Makers Market / Juneteenth / Make Music Weekend: Chairman Alter announced th that the Vintage Roadshow, Juneteenth Celebration, and Make Music Weekend will be the LSBD's first big event coming out of Covid now that the mask mandate has been lifted. The Vintage Road Show will feature 20 vendors and take place on the North end of Leland. University City Parks Department will bring the Bandwagon stage will be placed at Loop South and Leland. A robust schedule of bands playing throughout the weekend including the Red and Black Brass Band marching up and down Delmar. The LSBD has partnered with Alpha Kappa Alpha to put together an afternoon of Juneteenth performances at the Market in the Loop. All details are at UniversityCityLoop.com.

LSBD Budget / EDRST Request: Chairman Alter reported that he sent a letter to City Manager Gregory Rose requesting EDRST funds for Loop events and Free Parking through autumn. He will provide an update to the board next month.

Strategic Plan Update: Stephen Ibendahl from the i-5 Group will host another work study session on June 29, 2021.

Insurance Update and Street Cleanup: In Dan Wald's absence, Jessica Bueler reported that Dan has been working with Chuck Errant to complete an application for the LSBD's insurance policy. The LSBD needs to increase coverage amounts in order to hang up any banners in University City to promote Loop events. Dan is working on getting that completed this week. Free Parking: Chairman alter reported that he has submitted a letter to City Manager Mr. Rose to request the extension of free parking in the loop throughout the summer. He will report back to the board after receiving Mr. Rose's response.

Loop Brochures and Illuminated Directories: Chairman Alter met with Joe Edwards and discussed the board's desire to do a refresh on the brochure and that everyone's needs will be met.

Introduction of Assistant City Manager: Brooke Smith served as City Manager for East St. Louis for 2 years and has 10 years of local government experience. Ms. Smith is an attorney and has her Masters in Public Affairs. Her local government experience is in community and economic development and she will be taking over as University City staff liaison for the LSBD meetings. Chairman Alter and Wendy Harris asked Ms. Smith if at the next meeting if she could provide an update on the LED Lighting initiative on Delmar. Ms. Smith said she would work with Cliff Cross to see where he left off on this project and she will report back to the board at the July meeting. Chairman Alter also requested assistance from Ms. Smith with increasing the limit of the LSBD credit card.

Flower Planters in the Loop: Chairman Alter shared that he met with Judy Prange from U City in Bloom to discuss when flowers would be put in the planters and what else can be done to improve the look of the street. Chairman Alter also suggested the LSBD consider creating a "Paint a Planter" program and "Adopt a Planter" program and to continue discussing this at the next meeting.

Announcements: Wendy Harris announced that she received four cases of Explore St. Louis Magazines and they are available for any businesses that would like to pick them up from Artisans in the Loop. Jessica Bueler announced the next meeting will be held on Tuesday, July 13, 2021 at 10:00 a.m.
