#### **MINUTES**

## U City Loop Special Business District Board Meeting Via Tele Conference Tuesday, September 13, 2022 at 10:00 a.m.

**Attending Board Members:** Derek Deaver, Dan Wald, Michael Alter, Mary Gorman, and Cindy Liberman.

Absent Board Member(s): Steve Stone and Mohammed Qadadeh.

**Others on the Call:** City Manager Gregory Rose, Assistant City Manager Brooke Smith, Captain Fredrick Lemons, Jessica Bueler, Ryan Griffore, Joe Edwards, Audrey Jones, Marla Stoker Ballenger, Mike Giger, and one unidentified participant.

**Call to Order:** The meeting began at 10:04am with a quorum.

**Public Comments:** Joe Edwards congratulated police Chief Larry Hampton on passing the FBI's National Academy Leadership program. Mr. Edwards summarized Blueberry Hill's recent 50<sup>th</sup> Anniversary party. Mr. Edwards spoke about the positive media engagements surrounding the event and that Jordan Binnington presented him with a number 50 jersey to commemorate the event. Mr. Edward's also briefly highlighted some of the video congratulations he received from St. Louis natives John Goodman, Bob Costas, Andy Cohen, and Jon Ham,

**Approval of the Minutes:** A motion was made by Mary Gorman to approve the August 9, 2022 LSBD meeting minutes. Dan Wald seconded the motion. Without further discussion, the LSBD Board Meeting Minutes for August 9, 2022 were unanimously approved.

**City Hall Updates:** City Manager Gregory Rose shared that the City is in the final stages of cleanup and that bulk pickup for University City is on its final pass through to collect debris from the flood. City Manager Rose stated that the disaster recovery center is open as of August 26<sup>th</sup>, 2022 and that the Small Business Association is operating out of this location at the Centennial Commons. City Manager Rose also spoke about the Market/Olive development and that the Costco is scheduled to open September 25, 2022.

**Security Update:** Captain Fredrick Lemons thanked Michael Alter for allowing the police to do a security audit at Fitz's and for their access to his cameras. Captain Lemons encourages all Loop businesses to do the same. Captain Lemons is working on securing a date for an active shooter training session.

**Treasurers Report:** Dan Wald shared the financial details for August and that the LSBD started with \$55,135 and ended with \$45,789.

Loop Events and Marketing: Chairman Derek Deaver indicated that many attempts have been made to secure the ice sculptures without success. Chairman Deaver also shared that most vendors/entertainment needs to be booked six months to one full year in advance, therefore he is asking everyone to assist with Ice Carnival event if the board wants this event to move forward. Jessica Bueler detailed the marketing strategy timelines for getting LSBD events on the public calendars, to news agencies, and to the general public along with the importance of creating a calendar of events for 2023 as soon as possible. Michael Alter spoke about his multiple attempts to secure the ice sculptures and that he has not received a call back from the company. Ryan Griffore spoke about his attempts to secure the company for the ice sculptures with no success. Michael Alter suggested that this event might need to be smaller to secure the Ice Sculptures, and then the LSBD can transition to a more robust event the following year. Mr. Alter agreed with Ms. Bueler that the ice sculptures are a big part of the Ice Carnival and that without them, it's hard to have an Ice Carnival. Mary Gorman asked Michael Alter for the phone number for the Ice Sculptures. Michael Alter suggested one last attempt to secure the ice sculptures and if that fails that the LSBD board terminate the event. Derek Deaver suggested that if the LSBD runs the Ice Carnival, that it be a one-day event and that the Wash U. students should be included. Chairman Deaver expressed that he believes most businesses will be already be busy on the Martin Luther King long weekend. Mary Gorman expressed that she feels the students are one of the Loops biggest assets and that she is happy to move the Ice Carnival date to include the Wash U. students. Michael Alter mentioned that he believes the board shouldn't focus heavily on the Wash U. students when planning for events and that he is in favor of the original event date. Mr. Alter suggested that we can settle on a date after we have secured the ice sculptures.

Website and Social Media Accounts: Chairman Derek Deaver updated the LSBD Board about the expected standalone contract from the East Loop CID he received as being the exact same agreement that was originally sent to former chairman Michael Alter. Chairman Deaver indicated that this agreement did not fulfill the promises that was made to the LSBD about receiving control of the visittheloop.com website and that he feels the East Loop CID does not want to collaborate with the LSBD.

Mary Gorman asked Joe Edwards about what East Loop CID had planned for the Loop Ice Carnival. Joe Edwards responded that the Moonrise was going to do a Snow Ball which would be paid for completely by the Moonrise Hotel and that it would be the only contribution from the East Loop to the Loop Ice Carnival. Mr. Edwards offered to call a company from Texas to help secure the ice sculptures for the Loop Ice Carnival. Michael Alter indicated to Mr. Edwards that if he needed help with the securing the ice sculptures that he would reach out to him.

**Expanded Outdoor Dining Guidelines:** Chairman Derek Deaver informed the LSBD Board that Ryan Griffore sent a document to the board outlining the entire guideline and that the prototype construction at Three Kings Public House will begin on Monday. Chairman Deaver asked for input from the LSBD Board. Mary

Gorman suggested that the LSBD add a Certificate of Liability Insurance to hold the Landlord harmless incase anything happens in this newly created area. Chairman Deaver asked Ryan Griffore to add that document to the existing guidelines.

**St. Louis Walk of Fame & Planet Walk:** Chairman Derek Deaver mentioned that the City attorney and Mr. Edwards are working on this agreement. Chairman Deaver expressed his support for the St. Louis Walk of Fame but had some reservations on the Planet Walk signs and suggested that the LSBD keeps them right now and should discuss at a later date.

Old Business: There was no old business.

**New Business:** There was no new business.

**Public Comments:** Joe Edwards recommended having multiple DJ's for the Loop Ice Carnival for when people collect their temporary tattoos and ice coins. Mr. Edwards shared that he believes the updated Planet Walk signs should last longer than their originals.

Michael Alter asked Joe Edwards if he had any comments on the update about the social media accounts and website discussions with the East Loop CID. Joe Edwards stated he believed it was all resolved and that the East Loop wants to cooperate and that the tone he heard from the East Loop CID is different than the one he heard today during the update. Dan Wald asked Joe Edwards his opinion on who owns the visittheloop.com website. Joe Edwards said that it is in the hands of the East Loop CID and that once the contract is signed by the LSBD, that the LSBD would then be in control of it. Chairman Derek Deaver expressed to Mr. Edwards that the website control was conditional to giving up ownership of the Delmar Loop social media accounts and that those accounts would be run by a third-party which is costly and time consuming. Chairman Deaver shared that this contract made no logistical sense and that he was promised a standalone agreement for the ownership and control of the visittheloop.com website which the East Loop CID did not provide. Chairman Deaver mentioned that the LSBD created the visittheloop.com website and the Delmar Loop social media accounts and asked Joe Edwards who he thought owned those properties. Joe Edwards said that website and social media accounts are legally in control by the East Loop CID. Dan Wald stated that the website and social media accounts at one time were owned by the LSBD and that they are now owned by the East Loop CID. Mr. Wald asked Joe Edwards if there was a vote by the LSBD Board to transfer ownership of these accounts. Joe Edwards shared that he believed when Rachelle L'Ecuyer was hired it was to unify both LSBD and East Loop and that when University City stopped funding Rachelle's position that he believed the responsibility was forwarded to Jen Rieger. Dan Wald asked Joe Edwards why Rachelle L'Ecuyer would have ownership of the website and social media accounts as an employee. Michael Alter informed the LSBD Board that he has been a continuous board member throughout this timeframe and that he never voted at any time on transferring LSBD ownership of visittheloop.com website and social media

accounts to any other parties such as the East Loop CID. Mr. Alter believes that someone stole these assets from LSBD without approval and that this process was not legal. Mr. Alter expressed that it was important for the community at large during this public meeting to understand that Chairman Deaver, himself, as a former chairman, and City Manager Rose have all tried to get the social media accounts and website issue resolved while preserving collaboration with the East Loop and that their attempts have been unsuccessful.

Cindy Liberman took a moment to introduce herself as a new LSBD board member and that she is honored to be a part of the LSBD.
