
Adjournment: Motion to end meeting by Mr. Tieman; seconded by Ms. Jones. Approved by acclamation at 8:09 p.m.

Delmar Entrance Sign and Garden Concept Description.

This is an initial simple concept for the type of sign that should be installed at the intersection of Delmar Blvd and McKnight on the NE corner. Red brick was chosen for the wall to match the building on the corner and much of the architecture in University City. This will be capped with sandstone masonry. The elevated portion with the sign should be above the 4 foot tall by 1.5 foot deep brick foundation wall and be gray with the text carved in and blackened. The wall and sign will sit 2 feet above the grade of the lot and sidewalks on a berm. The flower beds should be 4-5 feet deep and fronted but 4 feet of turf for a total of 9 feet of ground from the sidewalk to the sign. Lighting and irrigation is to be included as well.

This concept will remove 10 – 12 parking spaces from the parking lot. This will require concrete removal to soil for the entire footprint. There will need to be a foundation to handle the weight of the sign. A good garden mix of topsoil should be brought in to surround the foundation and raise the grade by 2 feet. There are many things to consider including codes for height restrictions, electrical source for lighting, water source for irrigation, and choosing an engineer to measure elevations and grades and an architect to finalize the concept. Pricing will need to be done by an architect who understands material sourcing and costs and construction costs.

John's Redefinition:

For the purposes of the Municipal Commission On Arts And Letters, "art" or "work of art" is defined as any creation of aesthetic value. This definition includes, but is not limited to: literature; music; the plastic arts including tangible and physical forms of visual art such as painting and sculpture; jewelry; interior design; folk art; religious art; photography and film; installation art; architecture; conceptual art; records and recordings of performance art; landscape art and landscape architecture; live performance, or the records of the live performances of, to include, but not limited to, theater, ballet, opera, performance art, music, and other performing arts; creations that may be regarded as both aesthetically pleasing and ephemeral.

Revised Definition

For the purpose of the Municipal Commission on Arts and Letters, "art" or a "work of art" is defined as the result of creative expression that has aesthetic value. This definition incorporates the traditional seven forms of art: painting, architecture, sculpture, literature, music, performing arts, and film, but it may also include the decorative arts, e.g., ceramics and jewelry, also sometimes referred to as crafts, and the applied arts, e.g., interior design and fashion design.
