

Meeting minutes of the Board of Trustees for the University City Public Library for  
**September 28, 2022**

The meeting was held online due to the COVID-19 (novel coronavirus) pandemic. Board members and staff participated via Zoom, and the meeting was livestreamed for the public via the Library's Facebook page and YouTube channel.

A public hearing on the 2022 Library tax rate was opened at 5:17 pm. No members of the public spoke. Kim Deitzler made a motion to close the hearing. The hearing was adjourned at 5:20 pm.

The meeting was called to order at 5:21 pm by Helen Nelling, President, following roll call.

Minutes – Aren Ginsberg made a motion that the minutes from the special meeting on September 14, 2022 be approved, seconded by Kim Deitzler. Motion passed at 5:22 pm.

Librarian's Report – The librarian's report was added to the consent agenda for this meeting.

Discussion Items – Breakers for the project were ordered months ago but delivery may slip to April or May 2023 due to supply chain issues; the contractor is searching for another way to source the breakers. The Library will meet with RG Ross next week to discuss the issue of the windows leaking.

Action Items

*Adoption of Resolution 2022-2, regarding the setting of tax rates:* A resolution to accept the proposed 2022 tax rates for the University City Public Library district was passed unanimously by roll call vote at 5:28 pm. The tax rates on each one hundred dollars (\$100.00) of assessed valuation are:

- Residential property: thirty five and two tenths cents (.3520)
- Commercial property: thirty four and five tenths cents (.3450)
- Personal property: forty cents (.4000)
