### MINUTES OF THE MEETING OF THE URBAN FORESTRY COMMISSION UNIVERSITY CITY, ST. LOUIS COUNTY, MISSOURI WEDNESDAY, SEPTEMBER 14, 2022

### Agenda Item A: Call Meeting to Order

The meeting was called to order at 6:05 pm.

#### Agenda Item B: Roll Call

Those in attendance included Commission President Kristin Sobatka, Vice President Aaron Bitzer, Secretary Kathy Freese and Commission Members Dianne Benjamin and Dana Barhard. Also in attendance was Council Liaison Aleta Klein and Forestry Supervisor Jacob Kaiser.

### Agenda Item C: Approval of Agenda

Commission Vice President Aaron Bitzer motioned and Commission Member Benjamin seconded to accept the Agenda. The motion was approved unanimously.

### Agenda Item D: Approval of Minutes

Commission Secretary Kathy Freese made a motion to approve the minutes from the May meeting and Vice President Bitzer seconded.

### Agenda Item E: Citizens' Comments

Mr. and Mrs. Ruth residents at 7205 Watermann avenue made the case to appeal the city forester's decision to not have the city owned sweet gum tree in front of their home removed due to a sewer lateral interference.

Commission member Dianne Benjamin made a motion to give permission to the residents to remove the tree at their own expense and the city will be responsible for planting a new street tree. The motion was seconded by Aaron Bitzer and all commission members unanimously supported the decision.

**Agenda Item F: Department Report** – Forestry Supervisor, Jacob Kaiser reported on the Forestry Reports.

- a) July 26<sup>th</sup> flood created some issues with department operations
  - i. No forestry vehicles were lost
  - ii. Shop has been completely flood repairs are pending
  - iii. 6 chainsaws were lost to the flood
- b) 24 trees removed in July and August
- c) 352 trees were pruned in July and August
- d) Pruning contract is 72% complete

Removed 6 trees, 130 man-hours were spent on removals.

Pruned 3 trees, 22 man-hours spent on pruning.

Planted 26 trees, 72 man-hours spent on planting.

# Subject: OCTOBER FORESTRY REPORT

Removed 8 trees, 84 man-hours were spent on removals.

Pruned 15 trees, 44 man-hours spent on pruning.

Planted 57 trees, 200 man-hours spent on planting.

68 call/inspections completed by City Forester

Related forestry work:

- 3 Loads of woodchips were taken to Heman Park.
- 1 Loads of sweepings of bark and twigs were taken to recycle area in Ruth Park.
- 2 Loads of logs on the crane truck taken to Heman Park.

Comments:

93 trees pruned by contractor in the month of September.

Pruning contract is 97% complete

Most of the month spent planting trees

Emerald Ash Borer contract won by Omni tree service- work to begin in November

Hazardous tree removal contract won by Monster tree service- work to begin in November
