- 3. Agenda Changes and Approval of Agenda
 - A. Mr. Tate requested the following changes to the agenda;

1.) Honorary Street Name – Ferguson Ave., May be discussed but no action will be needed.

2.) No Commercial Trucks – North and South.: Now have recommendations for this item

- 3.) Speeding Music Neighborhood; Items can be discussed but is out to the Traffic Engineer for more study.
- 4.) Stop Sign Parking Enforcement University Park Subdivision. Item has been moved to another meeting, but item can be discussed.

5. Agenda items

A. Honorary Street Name – Ferguson Avenue .

1.) Applicant: Marie Ellis and Faye Ellis (1140 Ferguson Ave.) to change street name to Ellis Ave. to honor long-time resident and community activist.

- 2.) Staff recommendation is No due to existing concerns for fire and safety.
- 3.) Petitioners are aware of the recommendation of the staff.

4.) City Attorney Mulligan stated City Council has to establish an ordinance to make Honorary street name or change a street name. City Council has not brought forward an ordinance to do this to date.

5.) Suggestion by the commission that petitioners talk to their 3rd Ward council people to summit such an ordinance.

B. No Commercial Trucks – North and South

1.) Applicant: Mark Travers, 500 North and South, Apt. 201

2.) Conclusion/Recommendation: This area of North and South is City maintained, but lies between the portion that is in Clayton to the south and to the north is owned by ST. Louis County. The recommendation from Staff is that this section of North and South be improved with consideration to the road. The improvement would remove all the poor sections of the road and would be able to handle the truck traffic.

3.) City will resurface the city owned sections of the road and the county is in the process of resurfacing the remainder of North and South.

- C. Speeding Music Neighborhood (7300-7400 Wellington & Melrose Aves.)
 - 1.) Applicant: Sylvia Morris 7431 Wellington Ave.

2.)Note Discussion from previous meetings, Traffic flow is being studied with recommendations coming from neighborhood.

3.) Neighborhood is in process of gathering petitions for approval of changes.

4.) Staff has Traffic Engineer Reviewing previously presented options, City Staff is recommending Option 2.

- D. Stop Sign Parking Enforcement University Park Subdivision
 - 1.) Applicant: Brittany Rana OBO & Trustee of University Park Subdivision

2.) Request Cease enforcement of vehicles parking near stop signs because of the limited amount of space in the neighborhood for parking.

3.) Conclusion/Recommendation: City staff recommends that the police department update the commission on the recent enforcement of these violations. Although the rule as read in the City ordinance reads; "It is unlawful for the operator of a vehicle to stop, stand or park such vehicle in any of the following places, except when necessary to avoid conflict with other traffic or in compliance with the directions of a Police Officer or traffic control sign or signal. Within thirty (30) feet upon the approach of any flashing beacon or stop sign."

4.) Previous issued tickets are being resolved, thus this item was altered to a discussion item.

5.)There was a general discussion between Trustee Rana, Sgt. Whitley regarding what stop signs were city approved, subdivision posted and who maintains and enforces signs.

6.) Kathleen Watts , Trustee of University Park Subdivision requested "Where subdivision could get a list of the enforceable stop signs

7.) City Attorney Mulligan stated that the subdivision needs to get an approved list of enforceable stop signs from Public Work. This is code 300.

8.) Subdivision referred to public works to work on updating and moving signs.

9.) No commission action required or taken on this item.
