3. Approval of Agenda

5. Agenda items:

A. Williams residential parking permit.

Applicant: Cindy Newsom, 7069 Pershing

Location: Williams Avenue, between Pershing and Waterman

Request: Residential parking permit for residential parking only from 9 AM to 9 PM every day of the week.

- (1) Staff recommends that the traffic commission approve the petition.
- (2) Mr. Tate indicated the community had returned the petition with 75% of the necessary signatures which meets the criteria for the petition.
- (3) Commissioner Fuller made a motion to approve the petition: The residential parking petition to grant residential parking only on Williams Avenue, between Pershing and Waterman from 9 AM to 9 PM every day of the week. (This restriction matches the hours and days of adjacent streets).
- (4) Commissioner Tiers seconded the motion.

The motion passed by a unanimous voice vote of the commission.

6. Council Liaison Report: Councilman Hales indicated a hotel study has been done and four possible sites have been identified the best site seems to be the Forsyth by the old Famous Barr building. At the present time at least 3 hotels are considering proposals.

7. Miscellaneous Business:

- A. Commissioner Tiers questioned staff if any new information had been received from the county regarding the crossing at Center and Delmar Mr. Tate responded that the county has turned down any request from staff.
- B. Commissioner Tiers questioned speeding on Midland Avenue at Melrose. Sergeant Whitley indicated the portable speed unit would be posted for 21 days at Melrose Inn Mt. Vernon and then will get transferred to Midland in Melrose. The trailer provides the number of cars during peak times and the speed of each car.

8. Adjournment. Adjournment. No further business appearing, Commissioner Tiers made a motion to adjourn, Motion was 2nd by Commissioner Schaefer. Meeting Adjourned at 6:55 PM
