Councilmember Hales moved to approve Items 1 through 3 of the Consent Agenda, it was seconded by Councilmember Fuller, and the motion carried unanimously.

# L. CITY MANAGER'S REPORT - (voice vote on each item as needed)

**1.** Liquor License - 7-Eleven Sales Corporation, D/B/A 7-Eleven Store #20118Q, 8159 Olive Boulevard.

Mr. Rose stated staff is recommending that Council consider the approval of a Liquor License for the 7-Eleven Store located at 8159 Olive Boulevard.

Mr. Cole stated at the last meeting Council posed several questions about the impact of this license, and two 7-Eleven representatives; Stephen Mitchell and Rose Abernathy are here this evening to address those concerns.

Councilmember Smotherson stated he would acknowledge that this is a well-established location. So, his only concern is whether any changes would be implemented to ensure that the addition of alcohol does not diminish the quality of this popular neighborhood store?

Mr. Mitchell, Managing Officer for 7-Eleven, stated his understanding is that for roughly the past 20 years liquor was being sold at this location. And the reason for this request is that after the owner retired and the store was turned over to corporate, the employees recognized that they needed a Liquor License from the City in addition to their State Liquor License. So, no changes are being made, it's just an effort to correct a mistake.

Ms. Abernathy, Training and Development Officer for 7-Eleven, stated Mr. Mitchell is correct, this store has always sold liquor. She stated the program employees go through before becoming a floor associate that sells alcohol consists of a written exam, an online course, and a recap and review of their knowledge that she conducts. Corporate also participates in the State Bars Program which sends secret shoppers out to each location twice a month to monitor the sale of alcohol and cigarettes. Ms. Abernathy stated if an employee is caught selling liquor to a questionable or underage customer, they are fired immediately.

Councilmember Smotherson asked if 7-Eleven had a policy regarding loitering? Ms. Abernathy stated loitering is not allowed. And while the goal is to handle each situation respectfully, the manager of this location not only worked closely with the Police Department, he offered them free coffee and food because he liked to have their presence in the store to deter this type of behavior.

Councilmember Clay asked if a patron or member of the community would be able to notice any differences between a franchise and a corporate-owned store? Ms. Abernathy stated in some locations they might notice that a franchisee is a little more lenient about adhering to company policies.

Mr. Mitchell stated he had a conversation with the officer that worked with the previous owner for 19 years, who stated that he had never had a problem at this location. So, the goal is to continue that same type of outstanding service.

Councilmember Hales asked either the City Manager or Attorney if they could explain what is and is not permitted under this license to ensure that 7-Eleven has a clear understanding of the City's expectations.

Mr. Rose stated the Applicant has applied for "intoxicating liquor not more than 22% by the retail package," and a Sunday sales for "intoxicating liquor not more than 22% by the retail package". The address on the application is 8159 Olive Boulevard.

Councilmember Hales asked whether the Code permitted the sale of individual or single-serve alcoholic beverages? Mr. Mulligan stated the Code's definition of package is "at least three beers in a container".

Mr. Mitchell stated he could guarantee that 7-Eleven would abide by that definition and not sell individual beers to its patrons.

Mr. Mulligan questioned whether the information provided on the application for Sunday sales was correct; "at least 50% of the gross income of the restaurant/bar at this location is derived from the sale of prepared meals of food, or food consumed on the premises"?

Mr. Mitchell stated they have a new paralegal that may have checked the wrong box because while 7-Eleven does sell food, it's a convenience store, not a restaurant or a bar. So, he will work with City staff to get that corrected.

Mayor Crow asked when the control from franchise to corporate occurred? Ms. Abernathy stated it's been within the last few months. Initially, the franchisee thought he had a buyer, so we continue to run the license under his name until the buyer backed out.

Councilmember Smotherson moved to approve the application, with the stipulation that the application criteria related to Sunday sales be corrected, it was seconded by Councilmember Clay, and the motion carried unanimously.
