The meeting was called to order at 6:01 pm by Ms. Huether.

**Introductions:** John Tieman has been appointed Council Liaison for the Commission on Senior Services. He is excused from tonight's meeting due to a conflicting City Council meeting.

**Minutes**: Ms. Barry moved to approve the May 20, 2024 minutes. Ms. Curry seconded. Minutes approved by acclamation.

Citizen Comments: none

**Staff Liaison Report**: Ms. Euell-Taylor gave a brief report. The V.I.P. Pool Party was attended by 80 families. The fourth Thursday bingo event has moved to the Heman Park Community Center with great success. Senior Commission Chair, Teresa Huether will be the guest bingo announcer for the June 27<sup>th</sup> event. The event space can only accommodate 100 people. There are currently 20 people on the waiting list to attend. This situation is due to the need for half the space to be sectioned off for displaced employees during on-going flood remediation.

Council Liaison Report: No report available.

## **New Business:**

Forty-three people attended the Lunch and Learn program at the U. City Library in June. The complimentary lunch was catered by Gourmet-to-go. The July 12<sup>th</sup> Lunch & Learn is posted on the U. City website for on-line sign-up. The program is AARP Protecting Yourself from Scams.

Aging Ahead has requested a list of programming recommendations for resuming activities at Trinity Church. Mary Dee Schmidt has suggested chair yoga and crafts.

MS Huether mentioned music, meditation and movies. There was discussion of food distributions with a small donation. There will be pone program per meeting. Aging Ahead can offer transportation. Individuals requiring transportation must arrange it directly with Aging Ahead. University City does not provide transportation.

# **Old Business:**

Discussion of the Senior Services Coordinator position was deferred due to John Tieman's absence. Ms. Huether has actively recruited for this position, contacting several people seeking a qualified candidate. Applicants must wait until the job is posted on July 1st and apply through the proper channels.

Other updates/Topics of Concern: Ms. Huether introduced a new project pending for this Fall: Seniors Serving Seniors.

Ms. Huether stated that University City no longer has a communications person. There is no one to contact regarding the website.

Adjournment: Ms. Huether motioned for adjournment at 6:42pm. Ms. Barry seconded.
