The meeting was called to order at 4:00 pm by Ms. Curry.

Introductions: Dr. Samuel Martin, Coordinator of Student Transitions from University City High School was introduced by Ms. Curry.

Minutes: Ms. Schmidt moved to approve the September 16, 2024, minutes. Mr.

Lhotak seconded.

Citizen comments: None

New Business: Dr. Martin joined the commission meeting for a discussion of a proposed senior/youth program collaboration. Everyone agreed the main goal of this "lunch and learn" project would be to create an opportunity for meaningful exchange between the generations. Possibly the sessions could be scheduled during one of the 3 lunch periods, for approximately 45 minutes. Lunch would be provided by the school. Two pilot sessions, possibly in February and April of 2025, including 5-10 students and seniors would be a first step. No need for senior background checks if on school grounds, with certified teacher present. John Tieman explained that as a retired teacher from Soldan High school, he is still certified (maybe helpful). Dr. Martin will determine discussion topics with interested students. Ms. Schmidt will draft a summary proposal to be forwarded to Dr. Martin. Perhaps the pilot sessions can be facilitated by members of the senior commission. Dr. Martin and the senior commission members are encouraged by the possibilities. The commission members will refine the proposal & follow-up with Dr. Martin.

Staff Liaison Report: Ms. Euell-Taylor gave a brief report. The fourth Thursday bingo event continues to be a success. The assistant fire chief will be the guest bingo announcer for the October event (fire prevention month). The Senior Services

Coordinator position is posted on the website. John Tieman offered to inquire with the City Manager.

Council Liaison Report: Mr. Tieman gave an update on building construction in University City. The Circle K at Olive & Hanley will relocate across the street to the former's Pete's Grocery location. A Pietro's Italian restaurant will open in the former service station at Hanley & Delmar. A Dierbergs and an Aldi's grocery store are both planned for the Olive Rd – I-170 development. A task force to achieve environmental net zero carbon emissions is planned. A kick-off meeting is scheduled for October 28, 2024, at 5:30pm on the 6th floor of the City Hall building
