Planted 8 trees, 40 man-hours spent planting.





We are writing to inform you of an upcoming sidewalk improvements project in your area, scheduled to begin in the Spring of 2025. As part of this project, we will be making sidewalk improvements along public right-of-way (ROW), from Olive Boulevard to Melrose Avenue. This project will include the construction of new sidewalks, curbs, ramps and signage.

During the planning and assessment phases, it was noted that certain trees along the right-of-way are in conflict with the planned construction. If these trees are not removed, their roots will be disturbed during the construction, potentially causing damage to the trees or leading to their decline, which could create hazardous situations. Removing these trees is necessary for the timely and safe progression of the sidewalk construction project. This action is critical to avoid further delays and to help us stay on track with the project timeline.
