**Agenda Item A: Call Meeting to Order**

Jacob provided the following Forestry Department report for the year.

Staff removed 166 trees. Planted trees again remain short of the number removed.

A new staff member has been hired and on the job two days. Jacob is again asking for a third position to be hired.

Jacob reiterated that the City Manager wants to review our report prior to any presentation and will comment soon. Jacob will distribute those comments to the commission. The commission will provide a revised copy prior to the study session.

Jacob reported that the latest storm did not impact any trees.

New goals for 2025 included methodically working through the existing Forestry Management Plan and preparing an updated summary by the March 12 meeting.

To learn more about the technical aspects commission members will distribute information on free web seminars and podcasts.

It was noted that improved communication must again be a formal goal. A Forestry calendar for the year is one idea.

It was suggested we create a speaker series where we present the Forestry Commission Agenda at locations such as the Green Center, the Public Library and elsewhere.

The 2024 Annual Report will be updated for 2025.

Theodore Smith indicated he is interested in joining the commission. Dennis needs to nominate Theodore after he formally applies for the commission role.
