**Agenda Item A: Call Meeting to Order**

**Agenda Item E: Department Report**

a. Pershing and Ferguson Sidewalk Projects update.

Ferguson.

In order to update sidewalks and curbs, 19 trees in good to poor condition were removed. Otherwise, there would be too much interference with sidewalk placement.

Funding TAP (Trim Alternatives Project) 80% fed funded and U. City funded replacement and removal of trees.

Pershing

81 trees removed (79 city and 2 private) Need to be down prior to March 31 due to Indiana brown bat protection regulations per DNR, Funding is Surf Transportation Program 80-20 plus tree costs to city.
