1. Review and Discussion of Farmers Market/Centennial Commons use agreement – earlier in 2025 the Parks Commission approved for the use of Centennial Commons parking lot, this was a temporary agreement, and it expires on November 30th. Deb Henderson spoke about rules that are park/pavilion rules

that are being applied to the Farmers Market as the city was asking them to comply with these rules as renting the parking lot was being equated to a pavilion rental. The issues Deb has with the rules are: 1. No animals at the market. They are requesting to host a petting zoo at the market, a few times a year. 2. Food trucks – they would like an existing vendor that is looking to come with the farmers market, the Farmers Market generally doesn't want the food trucks. 3. Concerns about paying for using the parking lot when it rains and it has to be canceled. Josh made a motion to move forward with the contract with a variance to allow for a petting zoo and a waiver for fees if the market is canceled due to weather, seconded by Lisa, all in favor

2. Storybook/Ready Readers Program – Update, Review, and Recommendation of Park Location(s) – U City has had temporary Storybook Walks in the past. Ready Reader is currently looking to add permanent Storybook Walk into a U City Park, with the preference being adding the Storybook Walk into Fogerty Park. Ready Readers updates the stories in the Storybook Walk quarterly and they are responsible for the maintenance of the Storybook Walk. John made a motion to approve the installation of a Storybook Walk in Fogerty Park with the potential of adding a little lending library to the walk, and Josh seconded, all were in favor.

L. COMMISSION COMMENTS

Amy thanked Lynda for working with the school district on soccer fields for the fall and shared that the school district has approximately 400 children interested in basketball for the winter.
