### **Minutes**

Chairman Westbrooks called for approval of the January 28, 2025, meeting minutes. Minutes were motioned by Member Forsha, seconded by Member Isenberg. Approval carried unanimously.

### **Proposal from Baker Tilly on Analyzing the Police & Fire Employees Retirement System**

A proposal before you from Baker Tilly to analyze the Uniform Retirement System. The need for the analysis is due to the current trajectory of where the Plan is going, downward.

Andy Belkamp, from Baker Tilly, is present. He has over 20 years of experience in the City Government. The last 15 years been a consultant representing Cities, Counties, local Government, primarily in the finance area such as pension systems.

In Missouri, there are over 90 different defined benefit pension systems, about a dozen of those are statewide, and remaining are municipalities, and various transportation boards.

The objective is to make the Uniform Plan a more sustainable plan. What are our obligations to ensure that this Plan is sustainable for the future and for our retirees.

Member Isenberg made a motion to recommend this company, Baker Tilly, to perform this study, and to be funded by the City. The motion was seconded by Member Coley. The motion carried unanimously.

### **Disbursement Approval**

Chairman Westbrooks called for approval of the March 31, 2025, disbursements. Motion was made by Member Coley to accept the disbursement report, and it was seconded by Member Deitzler. Approved with unanimous consent.

Member Coley had a question about expenses related to Insurance - Disability.

Note: Mr. Cole is working with HR to gain further clarification.

Member Forsha made a motion to switch cash on deposit to move \$2 million for cash on deposit after we switch to Mix #5. The motion was seconded by Member Isenberg. The motion carried unanimously.
