Andy Belknap from Baker Tilly Advisory Group LP, made a presentation on the University City Police and Fire Pension Analysis – Observations and Recommendations. Mr. Belknap proceeded to go through the report and highlighted various key points and recommendations.

Next steps would be to have this report and a presentation to the Mayor/Council.

Legal Update from Heather Mehta

Heather Mehta gave an update on three (3) items. Everyone should have received an invite to the UB Greensfelder annual trustee training that satisfies your two hour continuing education that you need annually. The training will be on Wednesday, November 12, at the Lodge of Des Peres.

Missouri passed a statute prohibiting investments in certain restricted investment entities such as in China.

At the last meeting we discussed Purchase of Creditable Service. The Board should have a policy on this. Drafted policy and application have been included in the packet.
