# MEETING OF THE HUMAN RELATIONS COMMISSON OCTOBER 18, 2012 6:30

#### 1. NEXT STEP WITH SCHOOLS:

Victor Pichon, who works in the schools with REAL TALK, shared with the Commissions some of his observations of the students. He feels that poverty is the significant issue in terms of the kids with whom they work. These are students deemed "at risk" by the administrator at their school. They work at elementary, middle and high school levels. Mr. Pichone talked about the number of students who are dealing with PTSD as a result of the level of violence in their lives.

It was decided that we would invite Mr. Muhammad, who directs REAL TALK, along with Mr. Pichon, to our November meeting to discuss how the Commission might be helpful in letting people know about the work of REAL TALK and possibly helping with recruiting volunteers.

# 2. RELATIONS BETWEEN AFRICAN AMERICAN CUSTOMERS AND ASIAN AMERICAN BUSINESSES

Ellen Bern, Director of the University City Chamber of Commerce, joined the Commission for this discussion. The outcome of the discussion was that we would find ways to continue the discussion, including representatives of the Asian American business community. There were three points that were being considered:

- •treatment of African American customers
- •involvement of Asian American businesses in the life of the community
- •connection between Asian American businesses and other businesses in the U. City community.

We decided that we would continue to discuss this as a Commission at our next Commission meeting.
